PROCEDURES FOR RECOMMENDATION AND AWARDING

Trail of Tears Remembrance Association, Inc. is awarding scholarships to students of Native American descent, from tribes originating in the Southeast. The students awarded these scholarships shall have demonstrated successful academic performance and financial need. Applicants must provide evidence of enrollment in a Federal or State recognized tribe or be able to verify at least 1/16 Native American heritage. Applicants are responsible for researching their own family heritage; please refer to the Frequently Asked Questions Section for suggestions on verifying the information. Academic achievement & financial situations will be a consideration.

- These scholarships are for students that will be attending the university beginning in the spring of 2009.
- Questions 6 - 8: Please use your 2007 income tax return information. If you live independently of your parents and received no financial support or if you are married and do not receive support from your parents, please indicate that and skip and go to questions 9 – 13
- If your parent's financial situation has changed and will be different for 2008, please indicate that with an explanation.
- Question 9 – If you did not work in 2007 but plan to in 2008, submit your estimated income for the year.
- Question 15 – Please list all financial aid you will be receiving for the 2008/2009 school year: scholarships, grants, endowments, etc.
- Scholarships will be awarded for \$5,000.00 or less depending on the school and availability of funds.
- You will ONLY be contacted if you are awarded the scholarship.
- Complete Transcripts must be attached; reports cards will not be accepted
- Cover Letter (one page) Expressing How This Scholarship Will Help & How You Can Assist The Native American Community In The Future
- One Letter Of Recommendation From Tribe or School Official
- You Will Be Required To Contribute 30 Volunteer Hours For The Trail of Tears Remembrance Motorcycle Ride or Your Tribe. Volunteer hours can include selling Trail of Tears merchandise at other Native American events or at the Trail of Tears Remembrance, assisting at powwows, however, just dancing or participating in a powwow does not qualify. You must perform the volunteer hours within the year you received the scholarship and provide documentation from a Trail of Tears board member or Tribal representation stating that you have fulfilled your hours.
- Applicant must provide evidence of enrollment in a Federal or State recognized tribe or be able to verify 1/16 Native American heritage with a notarized statement from a Federal or State recognized tribe.
- **Researching Your Heritage:** Applicants are responsible for researching their own family heritage. Genealogy research can be done at your local library.
